

ORDINANCES AMENDING ORDINANCE  
No. 6.0402, No. 6.0403, No. 6.0404, No 6.0404A and No. 6.0405  
OF THE CITY OF ALCESTER

BE IT ORDAINED, by the City Council of the City Alcester, Union County, South Dakota,  
that City Ordinance No. 6.0402, No. 6.0403, No. 6.0404 and No. 6.0405, be amended to read as  
follows:

- 6.0402. LICENSING: It shall be unlawful for any person or persons within the corporate limits of the City of Alcester, Union County, South Dakota, to keep, maintain, or have in his custody or under his control any animal or animals of the dog kind, without first having obtained a license so to do from the City Finance Officer as hereinafter provided and without having paid the license fee therefore.
- 6.0403. APPLICATION: Any person or persons desiring to keep, maintain or have in his custody or control by himself or agent, within the City of Alcester, Union County, South Dakota, any dog, shall on or before the 15<sup>th</sup> day of January in each year, make application to the City Finance Officer for a license to keep such dog. The failure to make application and obtain a license prior to February 1<sup>st</sup>, shall constitute a violation of this ordinance. Such license shall be effective on a calender year basis commencing on January 1<sup>st</sup> and ending on December 31<sup>st</sup>. Such application shall be in writing and on forms provided by the City Finance Officer of the City of Alcester. The application shall state the name, sex, age, color and other distinguishing characteristics of the dog and include the name, address and telephone number of the owner thereof. Furthermore, said application shall state that said dog has no vicious propensities so far as known to the applicant. Said application shall be filed in the office of the City Finance Officer of the City of Alcester.
- 6.0404. LICENSE FEE: The applicant shall at the time of making application for a license, pay to the City Finance Officer of the City of Alcester, an annual license fee in the sum of \$5.00 per dog for such license. It shall be the duty of the City Finance Officer, at the time of the issuance of the license herein provided for, to furnish and deliver to said applicant a metallic tag for each dog for which such license is issued. Upon the tag, shall be stamped or engraved the registered number of the dog and the year registered. It shall be the duty of the owner to place a collar around the neck of the dog and the metallic tag shall be securely fastened to the collar. In the event of the loss of any tag so issued, the City Finance Officer is authorized to issue a duplicate tag at no additional cost to the owner upon satisfactory proof by the owner that said metallic tag has been lost. It is the duty of the owner of any licensed dog to assure proper tagging of said animal as set forth herein. The failure to do shall be a violation of this ordinance.

6.0404A. PENALTIES: The penalty for failing to obtain a dog license or to properly display the metallic dog tag as hereinabove set forth, shall result in a minimum fine for the first violation of \$25.00. It is deemed a separate violation of the dog licensing ordinance for each 30 day period of noncompliance. The fine for all subsequent offenses shall not exceed the maximum fine as authorized for violation of the City ordinances of the City of Alcester.

6.0405. RABIES VACCINATION: No license shall be issued to any owner of any dog who does not present to the City Finance Officer of the City of Alcester, at the time of making application for such license, a certificate of vaccination for "rabies" issued by a veterinarian, duly licensed to practice veterinary medicine, which certificate must show the date of such vaccination and must state the period of time for which the dog is effectively immunized, which period of immunization must be for at least one (1) year from the date of the issuance of the license. In the event that the immunization period is less than one (1) year, the owner of said dog must immediately provide a certificate of vaccination for rabies to the City Finance Officer of the City of Alcester within fifteen (15) days from the expiration date of immunization. A waiver of vaccination may be issued by the Finance Officer of the City of Alcester provided the dog is too young for a vaccination to be administered. Failure to provide said certification or waiver as herein set forth shall constitute a violation of the dog license ordinance and subject the owner to the penalties as hereinabove provided.

The effective date of this ordinance shall be January 1, 2008.

**ORDINANCE AMENDING ORDINANCE REGULATING WATER AND SEWER USAGE FOR THE CITY OF ALCESTER**

BE IT ORDAINED, by the City Council of the City of Alcester, Union County, South Dakota, that a certain ordinance entitled "An Ordinance Regulating Water and Sewer Usage for the City of Alcester", dated July 1, 1980, as amended, be further amended as follows:

SECTION I: WATER RATES

The following water rate schedule shall apply to all water purchased from the City of Alcester:

<u>Usage</u>	<u>Water Rate</u>
Minimum bill for 0 gallons	\$13.00
Each 1,000 gallons @ \$3.50 per thousand or a fraction thereof	

The above rates apply based upon water usage on a monthly basis. A minimum of \$13.00 per month will be assessed against all water users.

Rates for water users residing outside the City limits of the City of Alcester shall be increased by \$1.00 per month.

From and after June 1, 2006 the City of Alcester shall not establish any new residential water hookups for services outside the City limits of the City of Alcester.

The rates for all inoperative meters will be figured based upon the average of the last three months water usage. The consumer shall immediately report any meter malfunction to the City Finance Officer of the City of Alcester.

SECTION XII: EFFECTIVE DATE

This amended ordinance shall be effective on the 1<sup>st</sup> day of July, 2008, and shall apply to all water bills to be paid on the 1<sup>st</sup> day of August, 2008.

BE IT FURTHER ORDAINED, that the remaining sections of this ordinance, as previously amended, shall remain in full force and effect except as modified by this ordinance.

**ORDINANCE AMENDING AN ORDINANCE OF THE CITY OF ALCESTER, SOUTH DAKOTA, REGULATING THE COLLECTION AND HANDLING OF GARBAGE AND RECYCLABLES WITHIN THE CORPORATE LIMITS OF THE CITY OF ALCESTER**

BE IT ORDAINED, by the City Council of the City of Alcester, Union County, South Dakota, that a certain ordinance entitled "Ordinance Regulating the Collection and Handling of Garbage and Recyclables Within the Corporate Limits of the City of Alcester" dated November 4, 1996, be amended as follows:

RECYCLABLE COLLECTION PLAN: The City Council for the City of Alcester in its discretion may require any current licensee at any time during the term of the garbage license issued hereunder or renewal thereof, or as a criterion for the issuance of a new garbage license hereunder, to establish a recycling plan. If requested by the City Council of the City of Alcester, the licensee or applicant for a license hereunder shall provide a plan of recyclable collection to the City Council of the City of Alcester. The purpose of the plan shall be to minimize the amount of garbage collected and disposed of at the solid waste disposal site as designated by the City Council of the City of Alcester. This plan could include curb side recycling or such other provisions as may be approved by the City Council of the City of Alcester. Responsibility for formulating a collection plan for recyclables, if requested, shall be upon the licensee and failure to provide an acceptable plan and acceptable recyclable collection shall be grounds for revocation of this licensee.

BE IT FURTHER ORDAINED, that the remaining sections of this ordinance shall remain in full force and effect except as modified by this amendment.
